

Missouri who just allowed their state business's such as being considered here to put the hard liquor into the grocery stores has a story that we do not need to replicate here in Kansas, Consider this, Alcohol use in past month among persons aged 12 to 20 is up 30%. Those among that same age group is approximately 107,000. Binge drinking in the past month in this same group that now can get their hard liquor in a convenience store is up 21.2% which is counted as 75,000 kids. What an indictment on Missouri. We don't need to replicate this unrighteous nonsense in this Great State of Kansas.

A poll that was taken some weeks back state and the people of Kansas stated 66% of them would prefer it stay as it is. We don't need our state to follow Missouri's rates as they jump greatly in the first year for DUI's and Alcoholism.
